# Safeguarding requirements

The post holder must undertake an Enhanced DBS Disclosure with list checks for both children and adults check prior to their employment and then on a 3-yearly update.

- To deliver psychological interventions and structures to the staff team to the frequency and quality agreed in the Service level agreements (training, consultancy, assessment, interventions)
- To ensure effective, accurate and timely recording of all inputs (ClearCare etc) and outputs (outcomes)
- To ensure packages agreed with key stakeholders are delivered to a high standard e.g. ATIC model packages of support agreed with LAs and CCGs etc.
- Relationships: The maintenance of good collaborative multidisciplinary relationships evidenced in positive feedback about our service delivery.

## Main duties and responsibilities

Our Therapeutic Care Service supports independent care providers who want to deliver specialist therapeutic care. In your role as Highly Specialist Clinical Practitioner, you will oversee the delivery of effective and integrated psychological support services for one of our partner providers, Essential Therapeutic Care in Aldermaston, Berkshire.

Essential currently have three small CQC and/or Ofsted registered residential services for adolescents with complex mental health needs and/or attachment and trauma difficulties. Many of the young people also have diagnoses of neurodevelopmental differences such as autism or ADHD. Essential are planning on opening a fourth home in the coming year. The primary purpose of these homes is to provide support to young people aged 13-25 who need to step down from inpatient mental health, or to prevent them from being admitted in the first place.

Your role will include embracing and implementing our ATIC™ model (Attachment & Trauma Informed Care) and embedding consistent, predictable ATIC components and structures within Essential.

This is a highly autonomous and empathic leadership role to oversee reflective practice, integrated leadership meetings, risk management meetings for young people, assessments, staff training in traumainformed practice, and formulation and planning meetings.

You may also provide routine therapy to the young people, or you may provide supervision to a specialist trauma therapist who is responsible for direct work with the young people. You will provide supervision to an Assistant Psychological Practitioner who will support on the delivery of both the therapeutic interventions and the systemic team structures that you will lead.

You will work within a systemic framework to manage risk, improve outcomes for children and young people and ensure excellent support to the teams.

You will lead on the delivery of a therapeutic service across multiple sites (assessment, interventions, consultancy, and training) and harness your clinical expertise to secure the best outcomes when working with professionals both within and outside of MCTS.

Your primary task will be leading on all aspects of delivery relating to our Attachment and Trauma Informed model of care. In order to achieve this, you will deliver:



- Quarterly integrated clinical assessment and formulation meetings for young people looked after within the homes to provide a thorough understanding of the young person's needs and therapeutic care planning to the network around the young person
- Written assessment reports and integrative therapeutic support plans for each young person
- Consultancy and specialist training in developmental trauma, attachment, and therapeutic parenting approaches for staff teams
- Weekly Clinical Reflective Practice group for managers and residential care workers
- Leadership and support for managers, to support the embedding of ATIC at all levels
- Facilitating Red and Amber State risk management meetings as needed
- Direct therapy with the young people, or supervision of therapy via a Trauma Therapist.

#### Key competencies for this role include:

- Broad knowledge base related to child and adolescent mental health, developmental trauma, neurodevelopmental comorbidities etc
- Understanding a range of models, theoretical frameworks, best practice guidance
- Synthesising knowledge and thinking critically and creatively in novel situations
- Making informed judgements on complex issues in a specialist field in the absence of complete information
- Psychological assessment
- Psychological formulation
- Psychological intervention
- Evaluation and monitoring of outcomes
- Communicating and teaching/training
- Organisational and systemic influence and leadership
- Supervision of clinical and non-clinical staff

#### Special Conditions of Employment:

- A satisfactory Disclosure and Barring Service (DBS) check at an enhanced level is required along with satisfactory references
- Registration with the Health and Care Professions Council (HCPC)
- A willingness to travel to be physically present in the homes

It is the nature of the work at MCTS that tasks and responsibilities are, in many circumstances, dynamic and varied. All staff are therefore expected to work in a flexible way when tasks arise that might not be specifically covered in their job description.
